- 2. The proposer and seconder should be either a life member or a member.

3. Membership:

- 3.1. Any person, who has written/illustrated, is writing/illustrating or is interested in writing/illustrating for children or any institution which has published or interested in publishing books for children is eligible to become a Member of the Association.
- 3.2. An individual Member of the Association shall be a person who has been admitted as a member according to the Rules of the Association, has paid the admission Fee and the Annual Subscription, has signed the Roll of Members and has not resigned or been removed from the Roll in accordance with the Rules.
- 3.3. Any one, who is a member/eligible to become a member, can enroll as a life member on paying the prescribed fee.
- 3.4. Besides members, the publishers of children's books, magazines and newspapers (with a column for children) are entitled to apply for Institutional-Membership on payment of Annual Subscription of Rs. 4,000/-.
- 3.5. The General Body may confer Honorary Life Membership on authors-illustrators who have made a significant contribution to children's literature.
- 3.6. The General Body may also name eminent persons as Patrons of the Association.
- 3.7. The address of the member shall be as at the time of application and as entered in the list of members unless otherwise intimated by them.

4. Subscription:

- 4.1. The Admission Fee of Rs. 10/- (Rupees ten only) and Annual Subscription of Rs. 400/- (Rupees Four hundred only) shall be payable by a member. Life member shall pay a lump sum of Rs. 4,000/- (Rupees Four thousand only) at the time of admission. The Institution will pay Rs. 4,000/- (Rupees four thousand only) to become an Institutional Member every year.
- 4.2. The annual subscription shall be payable in the month of April every year.
- 4.3. Members joining in any month of the financial year shall pay subscription for the full year.
- 4.4. No refund of Annual Subscription/Life Membership/Institutional fee shall be permissible under any circumstance.

(Only Life Membership of Rs.4000/- is acceptable and not valid for Annual Membership)
